

Government Decree 73/2020 (31 March)
on extending the duration of the extraordinary measures related to the state of
danger declared in 11 March 2020

The Government,
acting within its original legislative power laid down in Article 53(3) of the Fundamental Law,

acting on the basis of an authorisation by the National Assembly pursuant to section 3 (1) of Act XII of 2020 on the containment of coronavirus,

acting within its function laid down in Article 15(1) of the Fundamental Law,

orders as follows:

Section 1 The Government shall extend the duration of

a) Government Decree 46/2020 (16 March) on the measures to be taken during the state of danger declared for the prevention of the human epidemic endangering life and property and causing massive disease outbreaks, for the elimination of its consequences, and for the protection of the health and lives of Hungarian citizens (III),

b) Government Decree 47/2020 (18 March) on immediate measures necessary for alleviating the effects of the coronavirus pandemic on national economy,

c) subtitle 2 and subtitle 3 of Government Decree 48/2020 (19 March) on the measures to be taken during the state of danger declared for the prevention of the human epidemic endangering life and property and causing massive disease outbreaks, for the elimination of its consequences, and for the protection of the health and lives of Hungarian citizens (IV),

d) Government Decree 57/2020 (23 March) on the enforcement measures to be taken during the state of danger declared for the prevention of the human epidemic endangering life and property and causing massive disease outbreaks, for the elimination of its consequences, and for the protection of the health and lives of Hungarian citizens,

e) Government Decree 59/2020 (23 March) on the extension of eligibility for certain health insurance and family benefits granted with regard to caring for and raising children during the state of danger declared for the prevention of the human epidemic endangering life and property and causing massive disease outbreaks, for the elimination of its consequences, and for the protection of the health and lives of Hungarian citizens,

f) Government Decree 60/2020 (23 March) on measures necessary for improving the health security of contactless payments with regard to the state of danger,

g) Government Decree 61/2020 (23 March) on detailed rules concerning public dues of Government Decree 47/2020 (18 March) on immediate measures necessary for alleviating the effects of the coronavirus pandemic on national economy, and on certain new measures,

h) Government Decree 62/2020 (24 March) on detailed rules concerning payment moratorium of Government Decree 47/2020 (18 March) on immediate measures necessary for alleviating the effects of the coronavirus pandemic on national economy,

i) Government Decree 63/2020 (24 March) on measures related to medical research during the period of state of danger declared for the prevention of the human epidemic endangering life and property and causing massive disease outbreaks, for the elimination of its consequences, and for the protection of the health and lives of Hungarian citizens,

j) Government Decree 67/2020 (26 March) on measures related to the supply of medicinal products during the period of state of danger declared for the prevention of the human epidemic endangering life and property and causing massive disease outbreaks, for

the elimination of its consequences, and for the protection of the health and lives of Hungarian citizens,

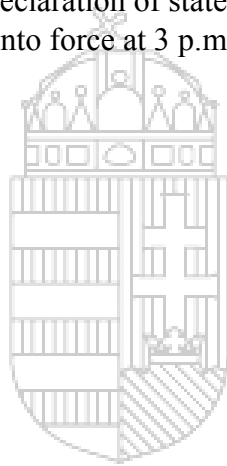
k) Government Decree 69/2020 (26 March) on derogating rules relating to the use of fiscal reserves during the period of state of danger declared for the prevention of the human epidemic endangering life and property and causing massive disease outbreaks, for the elimination of its consequences, and for the protection of the health and lives of Hungarian citizens,

l) Government Decree 70/2020 (26 March) on derogating rules relating to providing education and vocational qualification examination in adults training during the period of state of danger declared for the prevention of the human epidemic endangering life and property and causing massive disease outbreaks, for the elimination of its consequences, and for the protection of the health and lives of Hungarian citizens,

m) Government Decree 72/2020 (28 March) on hospital commanders and protecting healthcare supply

until the end of the period of state of danger under Government Decree 40/2020 (11 March) on the declaration of state of danger.

Section 2 This Decree shall enter into force at 3 p.m. on the day of its promulgation.
